  - No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
  - No child shall be subjected to physical punishment or mental harassment. II.
  - No child is required to pass any board examination till the completion of elementary 111.
  - Every child completing elementary education shall be awarded a certificate as laid down IV. under Rule 22.
  - Inclusion of Students with disabilities/ special needs as per provision of the Act. V.
